

Gun Purchasers

1. Pay First
2. Must Have PHOTO on Drivers License
3. Fill Out ATF Form
4. \$10.00 for every 3 GUNS - UNLESS the Gun Does Not Have a Serial Number, Then its 10.00 PER GUN !!!!!
5. DO Not Bid, Unless You Have Read GUN RULES.

DO NOT BID If You THINK You Will Be DENIED!!

If You Get DENIED, The GUN WILL Be RESOLD at YOUR EXPENSE!!!!

ATTENTION: Please check ALL Guns BEFORE Firing, they are sold as-is and some are out of an estate.

After 30 Minutes to 1 Hour or so, Check with the Cashier, at Window, to see if Your ATF form has been Approved. IF NOT, it May be Monday.

NOTE: Please Pick up Guns, NO LATER than 3 Days, After Check Has Been Ran. OR You Will Have to Be Rechecked & Pay Again!!!

Gun Rules

1. YOU MUST BE AT LEAST 18 YRS OLD TO PURCHASE A LONG GUN & 21 YRS OLD TO PURCHASE A HAND GUN. *ALL Pistol Grip Long Guns You Must be 21 Yrs Old to Purchase. ATF Form to be completed for Black Powders if it has an interchangeable barrel. ATF Form to be completed for GUN PARTS!!!!*
2. ATF Form MUST be completed , **REGARDLESS of GUNS AGE!!**
3. Your Address MUST Match your Drivers License!! ***THERE WILL BE NO EXCEPTIONS!!***
4. YOU MUST HAVE A **DRIVERS LICENSE W/ A PHOTO ID.**
5. *Any TOUCHING STATE, EXCEPT FOR VIRGINIA, MAY PURCHASE A LONG GUN ONLY**** TENN RESIDENT ONLY, CAN PURCHASE A HANDGUN!!! ALL Others will be Shipped to FFL Dealer ONLY. Will NOT Ship to C&R Collector!! ALL Black Powder Guns will be Shipped to FFL Dealer ONLY!!! NO Sales to California.*
6. **STRAW PURCHASE: YOU MUST be the ACTUAL PURCHASER of the FIREARMS. YOU & YOU ONLY, NOT intended for ANYONE else, NOT for spouse, friend, etc.**
7. DO NOT BID IF YOU ARE WANTED FOR ANY REASON OR OWE THE COURT ANY MONEY=PARKING TICKETS, CHILD SUPPORT, ETC. OR IF YOU HAVE ANY THING IN YOUR PAST THAT MAY STILL BE ON YOUR RECORD.
8. ***We DO NOT sell RESIDENT ALIENS GUNS.***

IF you are DENIED, The gun will be RESOLD, at YOUR EXPENSE!!!!!!

YOU CANNOT PURCHASE A GUN IF:

1. HAS BEEN CONVICTED IN ANY COURT OF A CRIME PUNISHABLE BY IMPRISONMENT FOR A TERM EXCEEDING 1 YR.
2. YOU ARE A FELON OR A FUGITIVE FROM JUSTICE.
3. A SUBSTANCE ABUSER.
4. DECLARED MENTALLY DEFECTIVE, OR COMMITTED TO A MENTAL INSTITUTION.
5. DISHONORABLE DISCHARGE FORM ARMED FORCES.
6. BEEN CONVICTED OF ANY ACTS OF VIOLENCE OR STALKING.
7. IF YOU ARE AN ILLEGAL ALIEN, RESIDENT ALIEN OR RENOUNCED YOUR CITIZENSHIP OF THE UNITED STATES.
