

Gun Purchasers

- ① Pay First.
 - ② Must have Photo on Drivers License.
 - ③ Fill out ATF Form.
 - ④ 10.00 for every 3 guns, unless no serial number, then 10.00 per gun.
 - ⑤ Guns to be picked up immediately following approval, any guns not picked up will be subject to another recheck.
- Guns are sold AS-IS: Firearms have not been tested or inspected for firing. Before firing, it is the BUYERS responsibility to have firearms inspected by a gunsmith. Buyer agrees to hold Powell Auction & Realty LLC harmless for any claim, injury or malfunction. ****Items not picked up or transferred within 10 days, WILL BE SOLD, without notice, for storage****

Gun Rules

1. 18 yrs old to purchase a long gun or long gun ammo. 21 yrs old to purchase a hand gun, pistol grip long gun or gun parts or hand gun ammo. *ATF Form to be completed for Black Powders & starter pistols if it has an interchangeable barrel . ATF Form to be completed for GUN PARTS and Regardless of guns AGE!!!!*
2. Your Address **MUST Match your Drivers License W/ A PHOTO ID!!** Guns WILL NOT be transferred until you have proper documentation!! **THERE WILL BE NO EXCEPTIONS!!**
3. Any **TOUCHING STATE, EXCEPT FOR VIRGINIA, MAY PURCHASE A LONG GUN ONLY**** TENN RESIDENT ONLY, CAN PURCHASE A HANDGUN!!!** ALL Others will be Shipped to FFL Dealer ONLY. Will NOT Ship to C&R Collector!! ALL Black Powder Guns will be Shipped to FFL Dealer ONLY!!! NO Sales to California or Hawaii.
4. **STRAW PURCHASE: YOU MUST be the ACTUAL PURCHASER of the FIREARMS. YOU & YOU ONLY, NOT intended for ANYONE else, NOT for spouse, friend, etc.**
5. DO NOT BID, IF: You are wanted for ANY reason. Owe the court ANY money! If you have ANYTHING in your past, that may still be on your record. If your drivers license does not match your address.
6. **We DO NOT sell RESIDENT ALIENS GUNS. US CITIZENS ONLY.**

IF you are DENIED OR if the gun OR ammo is not transferrable, The items, will be RESOLD, at YOUR EXPENSE!!!! (IF you are DENIED for a gun, NO ammo) No Refunds!

YOU CANNOT PURCHASE A GUN IF:

- ◆ Have been convicted in any court of a crime punishable by imprisonment for a term exceeding 1 year or under indictment OR You are a felon or a fugitive of justice.
- ◆ A substance abuser OR Declared mentally defective or committed to a mental institution.
- ◆ Dishonorable discharge from the armed forces OR If you are an illegal alien or renounced your citizenship in the US.
- ◆ Have a restraining order from harassing, stalking or threatening a person OR Convicted of a crime of violence.
